WHAT IS GRESB?

The GRESB (Global Real Estate Sustainability Benchmark) has established itself as a global ESG benchmark for real estate, making the sustainability performance of real estate companies and real estate funds transparent and comparable. The GRESB score from 0 to 100 measures seven categories, which evaluates environmental, social and economic sustainability. This is first calculated for individual properties and can then be applied to the entire portfolio. Score cards show you where you stand compared to your peers. The goal of participating in the GRESB rating is to achieve “Green Star” status.

GRESB tells you where your portfolio stands in relation to the competition, how you can improve it and provides decision-making support regarding whether improvements are economically feasible.


