ESG DUE DILIGENCE

Interest in sustainable real estate investments and responsible property use is growing - for good reason, as legislation is increasing the pressure on owners: those who do not sufficiently consider ESG criteria in their properties risk higher maintenance costs, poorer financing conditions as well as disadvantages in letting - and thus prospectively lower yields.

For a planned acquisition or sale, we therefore recommend an ESG audit as a fixed component of the due diligence: the environmental, social and corporate governance criteria are thus directly included in the assessment and both buyer and seller receive a clear picture of possible follow-up costs.

1 QUICK-CHECK

We determine the ESG characteristics of the property, identify red flags during portfolio acquisition or viewing using our own customisable and fund-specific C&W ESG Score Card, and check the assets' compliance with market trends as well as current and future legislation.

2 STANDARD ASSESSMENT

We provide in-depth information on the current ESG characteristics of your property, check EU taxonomy compliance and determine the decarbonisation path using the CRREM tool.

3 PREMIUM ASSESSMENT

In addition to the standard assessment, we offer you an initial assessment of possible certifications, determine the theoretical baseline assessment and point out optimisation potential. 4 PREMIUM-PLUS ASSESSMENT

For this purpose, we develop an individual net zero strategy and recommend concrete measures to reduce energy consumption and CO₂ emission in the short, medium and long term. Via a thermal-dynamic simulation, energy savings and investment costs can be estimated precisely.
