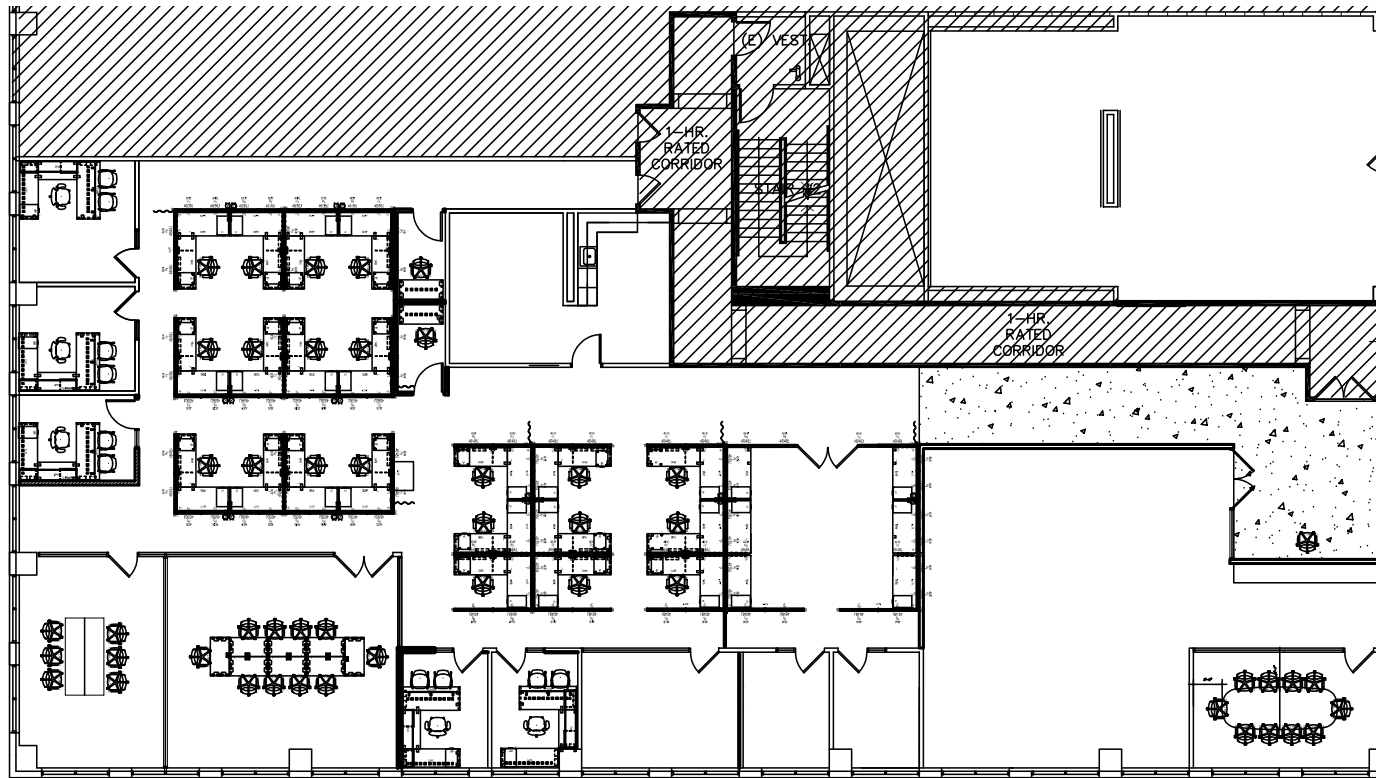

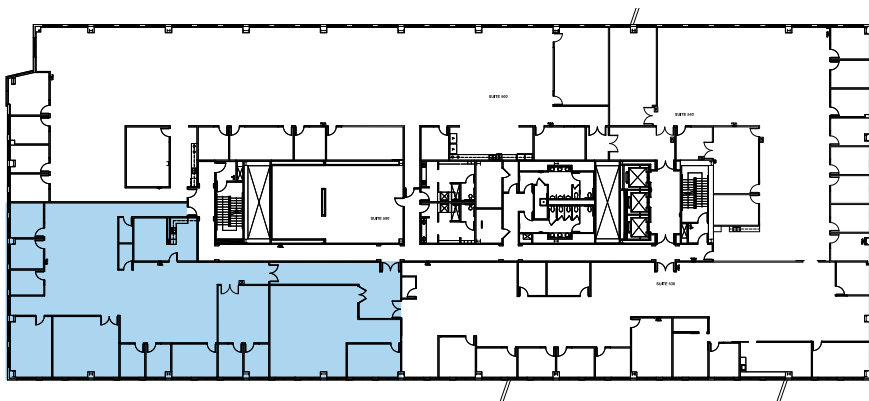


FLOOR PLAN
