




FLOOR PLAN



TRANSPORTATION



In an 11-mile extension of the Trolley Blue Line expanding from Old Town Transit Center and continuing to UTC Transit Station, San Diego looks to improve its public transportation segment. The new project headed by SANDAG, will include nine new stations, five with parking, and 36 new rail vehicles. These transit stations will include carshare, bikeshare, bike parking, ride share, and other technology to improve transportation. These benefits mixed with the existence of a new form of efficient public transportation will be responsible for 21,000 new daily boarding's, 8,600 fewer daily automobile trips and a reduction of CO2 emission by 260 metric tons per day. Construction is now 95% complete, and the project remains on schedule to begin service in late 2021.
