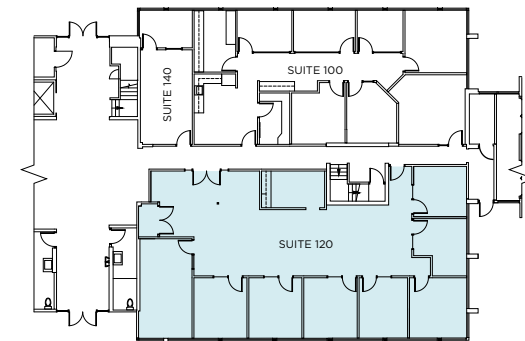
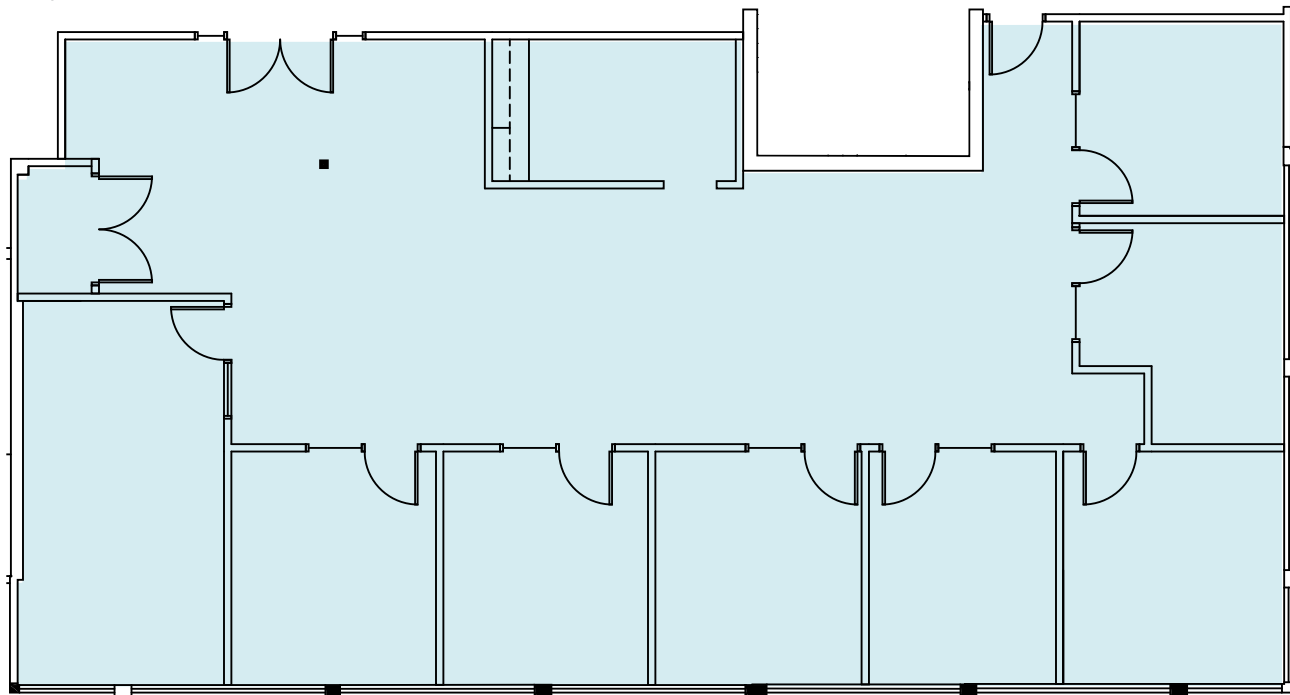




FLOOR PLAN

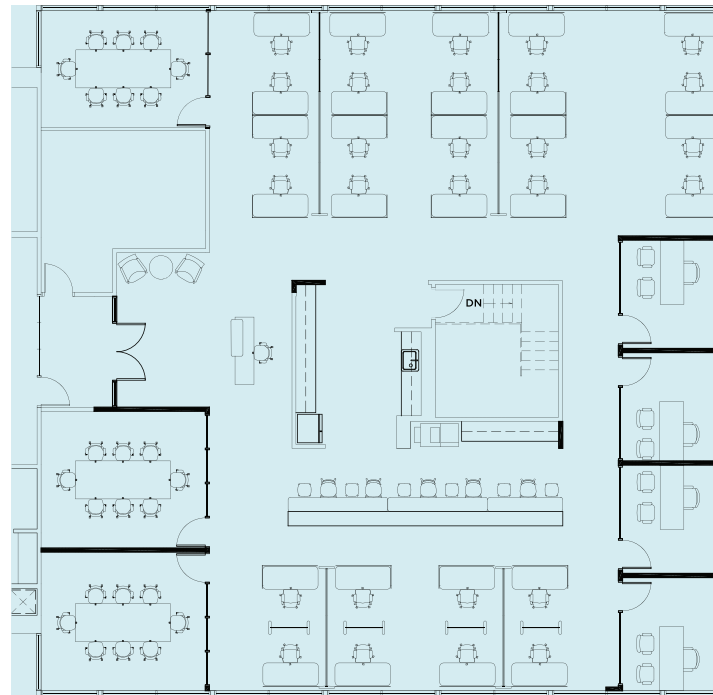
