
Ascension St. Vincent's is under construction on the 150,000 SF hospital that includes 56 beds, 8 intensive care units, emergency services, cardiovascular care, orthopedic and musculoskeletal care, general surgery, laboratory and imaging services.

The immediate trade area is seeing unprecedented rooftop growth, driving commercial demand. This is evidenced by the recent opening of the Publix anchored Shoppes at Beachwalk and the additional 187,000 sf of retail under construction.



### SURROUNDING **AREA GROWTH**


