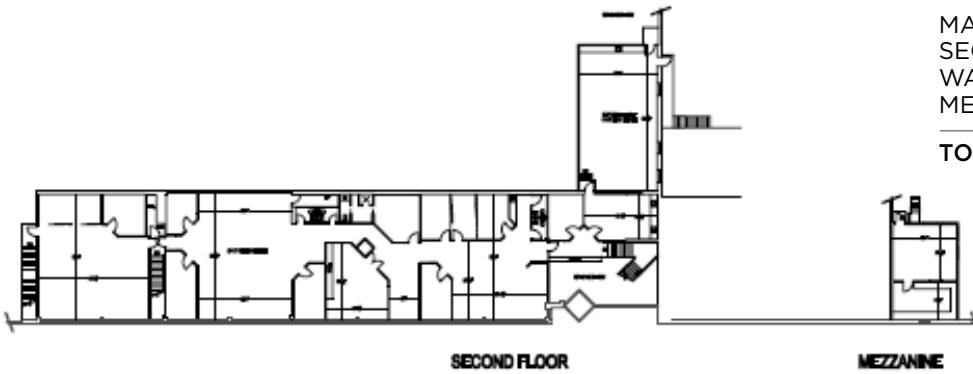
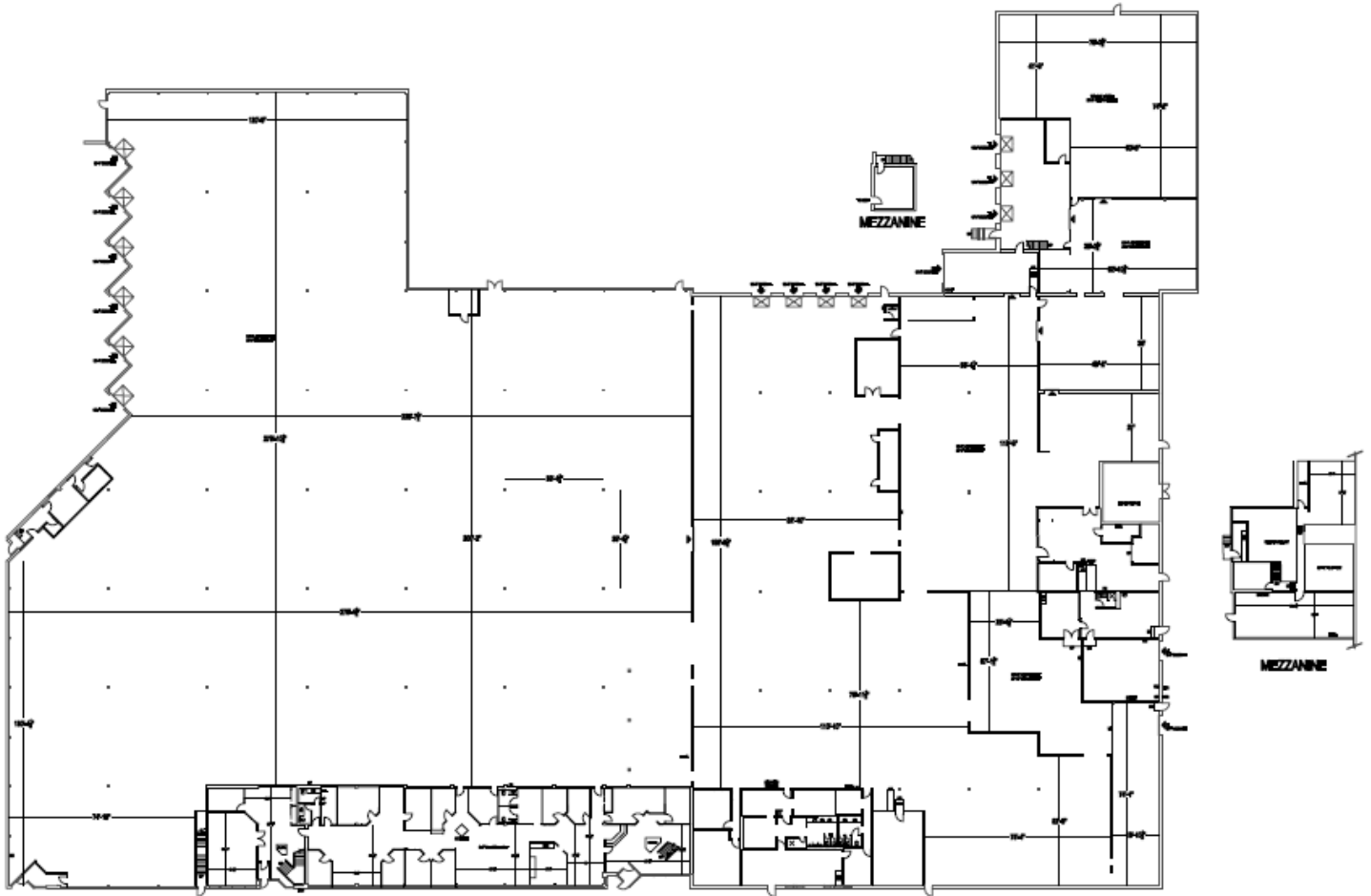

FLOOR PLAN

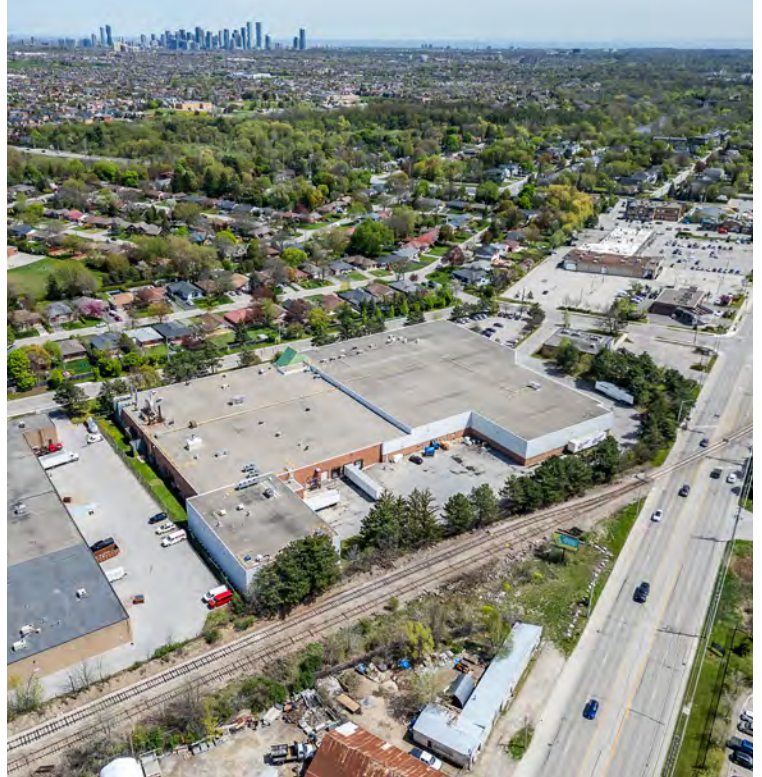

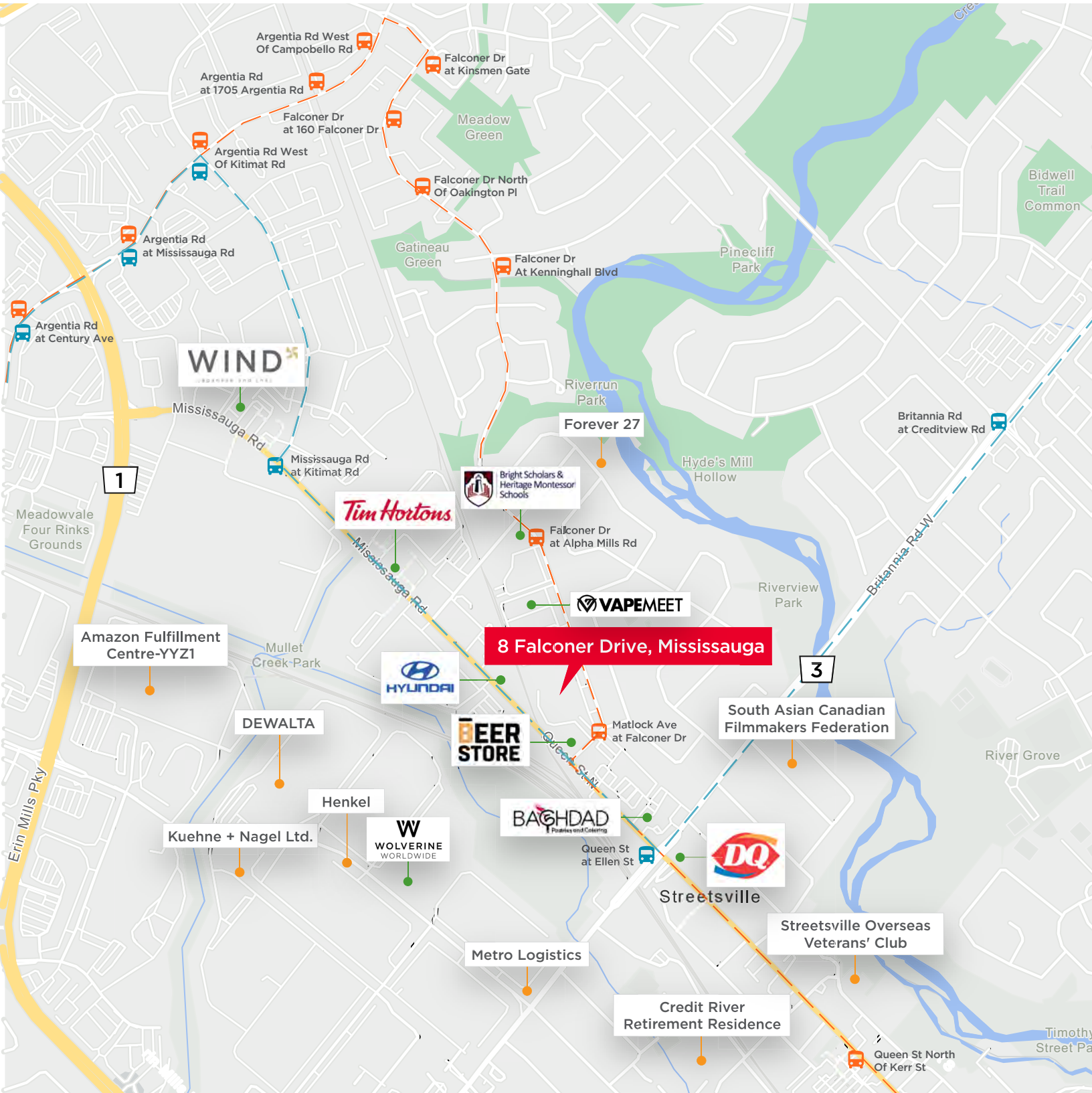

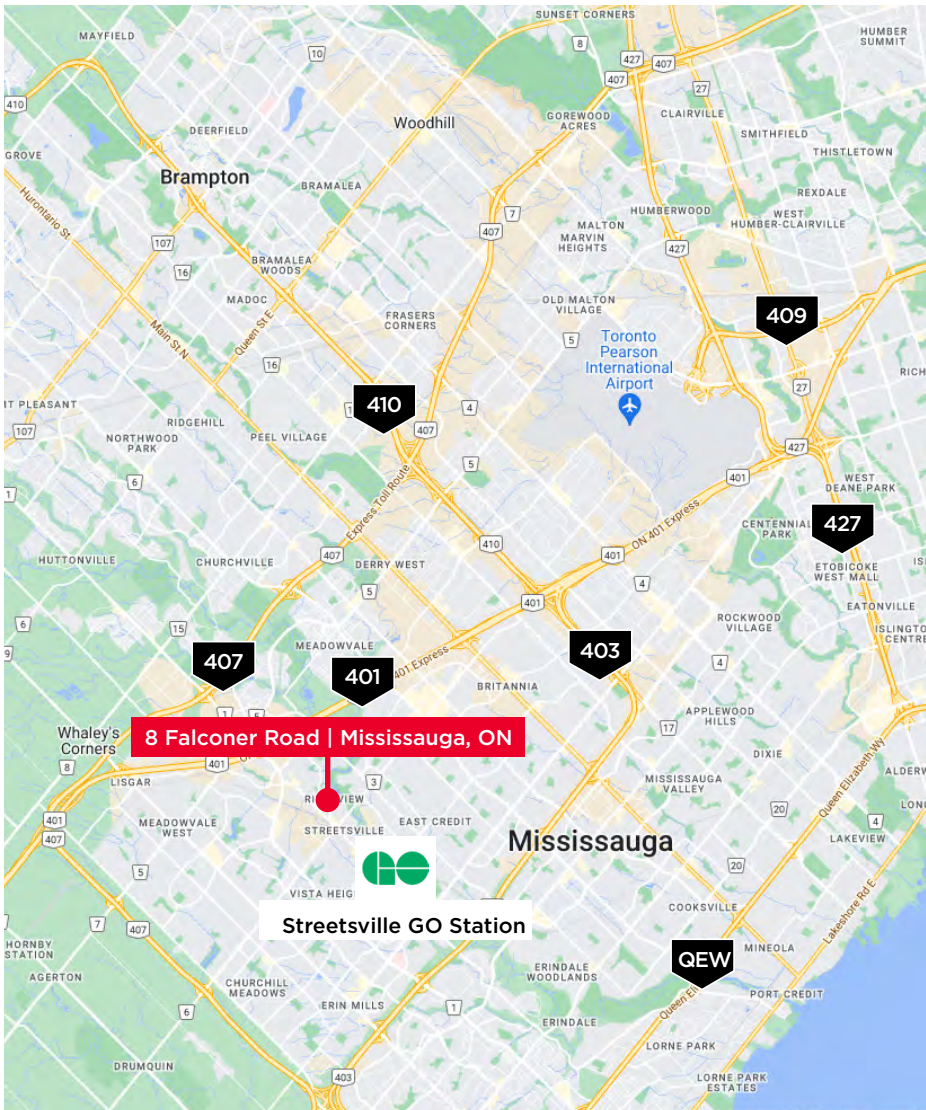
