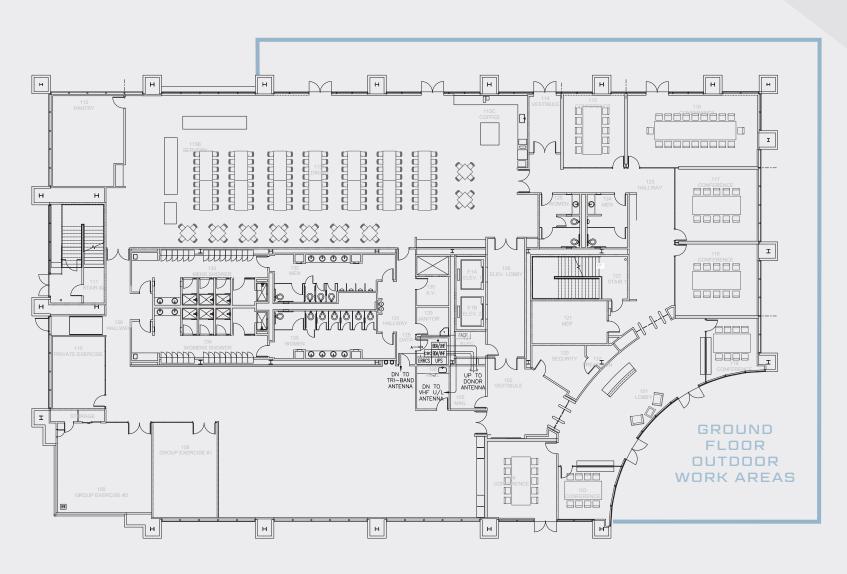


FIRST FLOOR

FLOOR PLAN



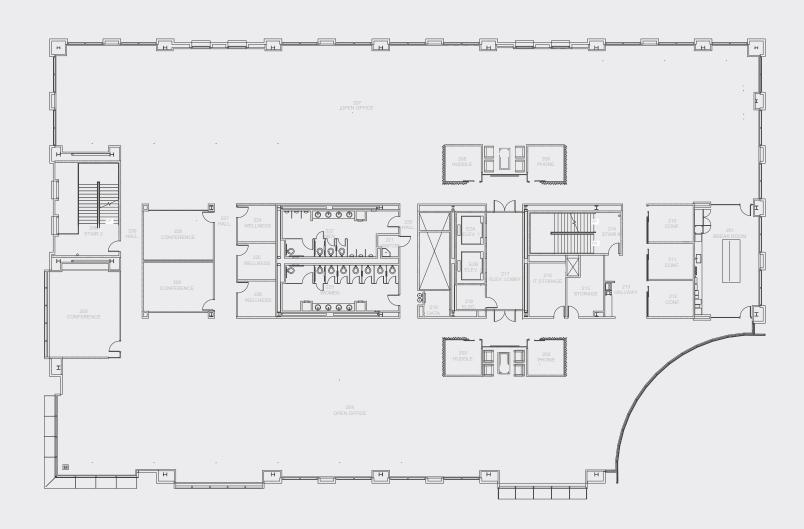

FLOOR PLAN

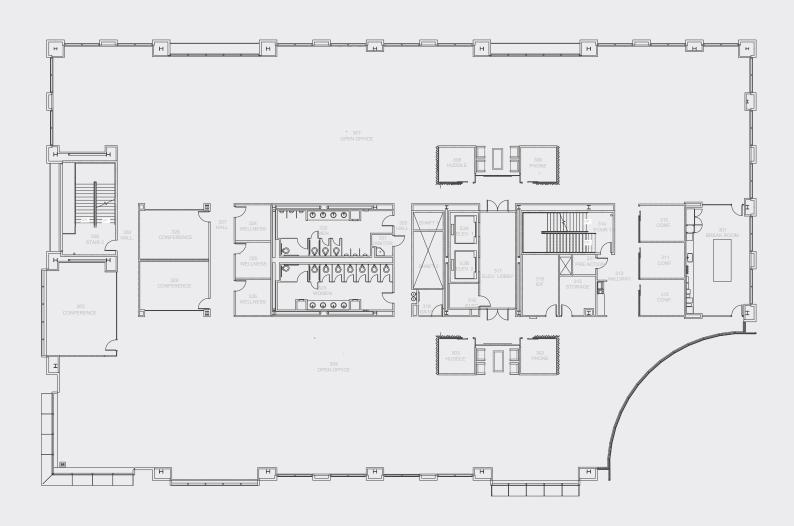


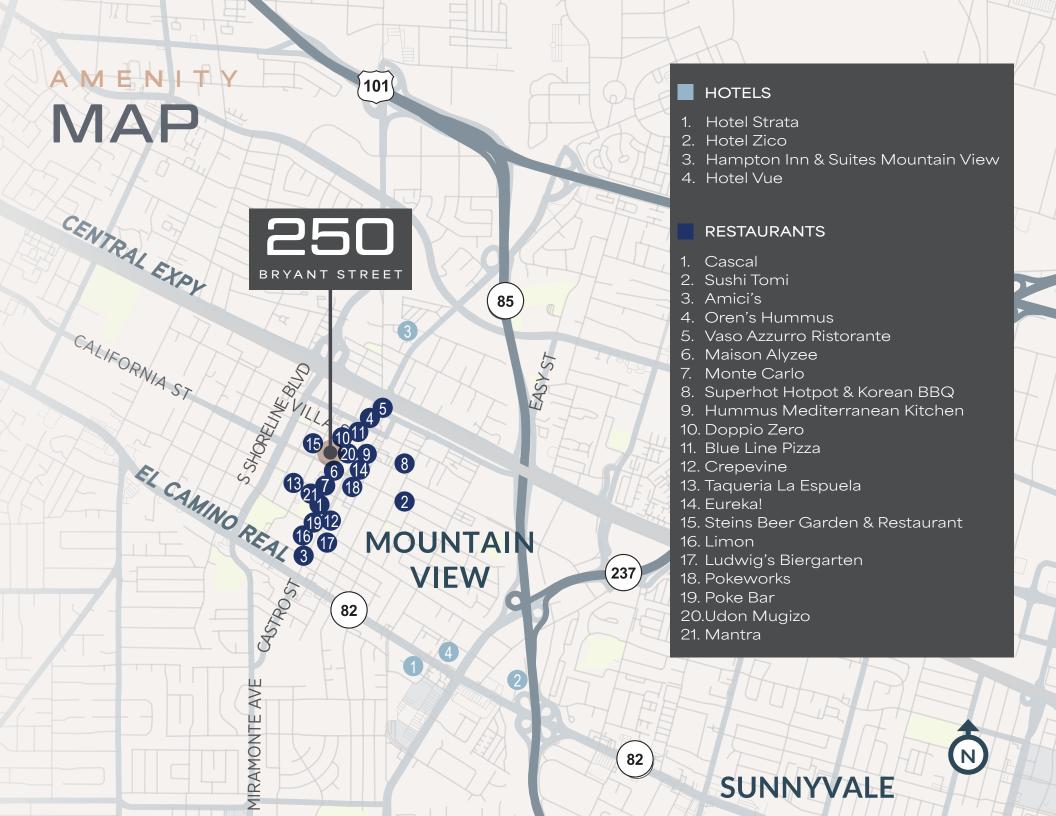


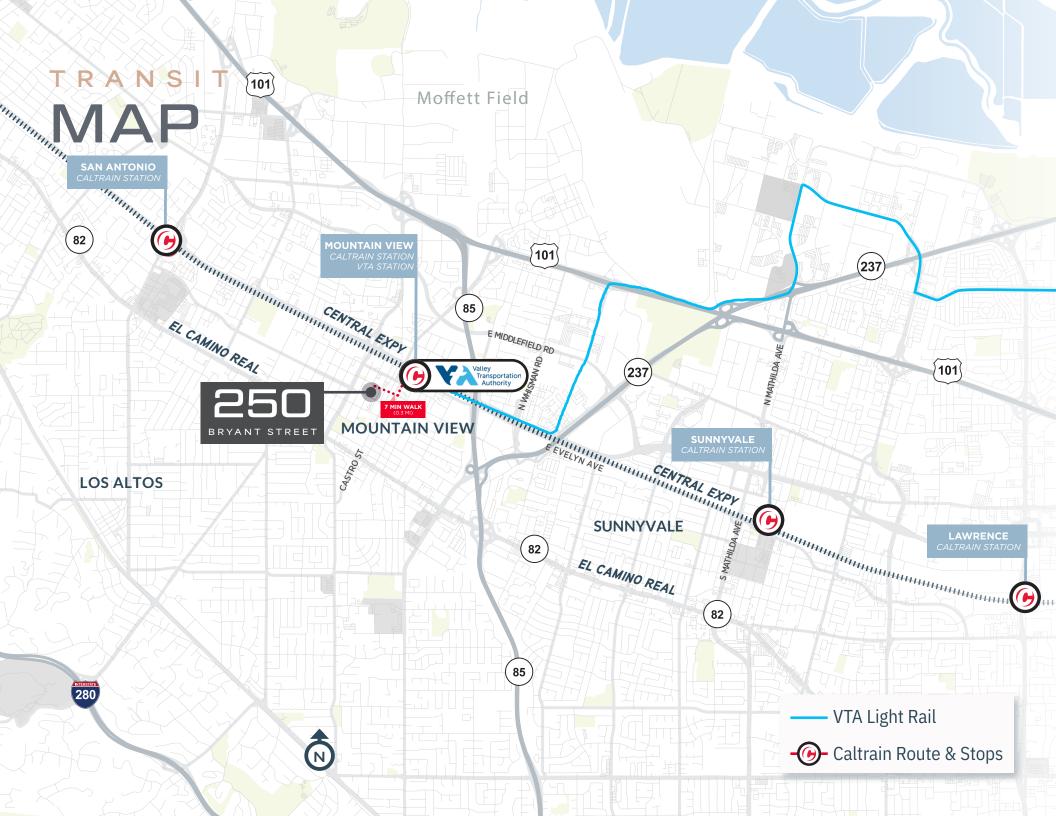
THIRD FLOOR
