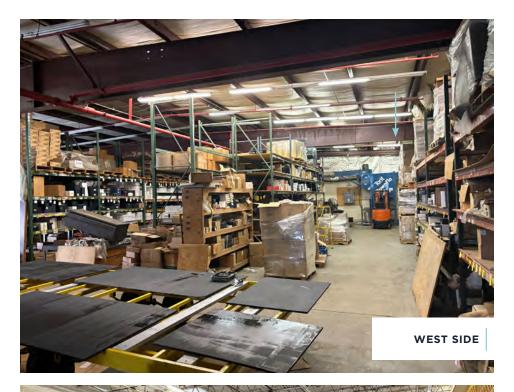

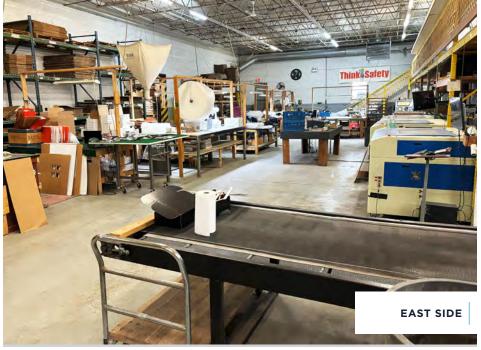

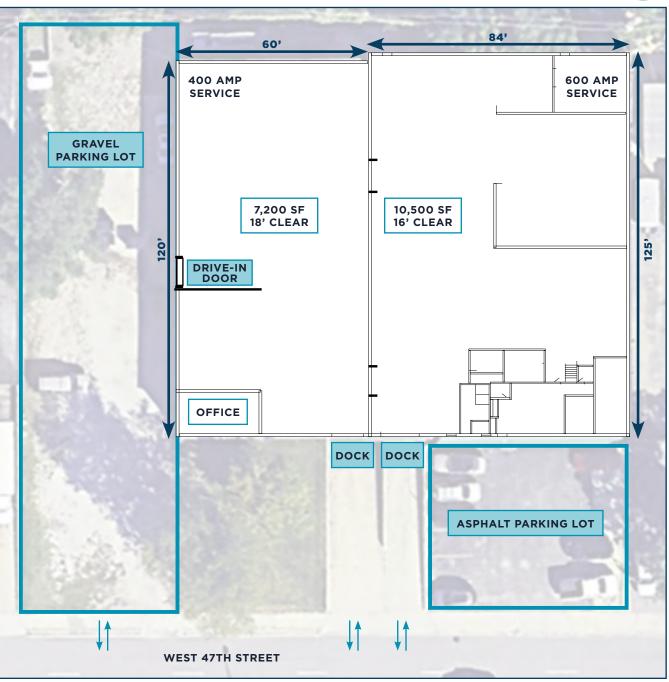
Functional industrial property with graveled and asphalt parking areas, and dock and drive-in loading.
