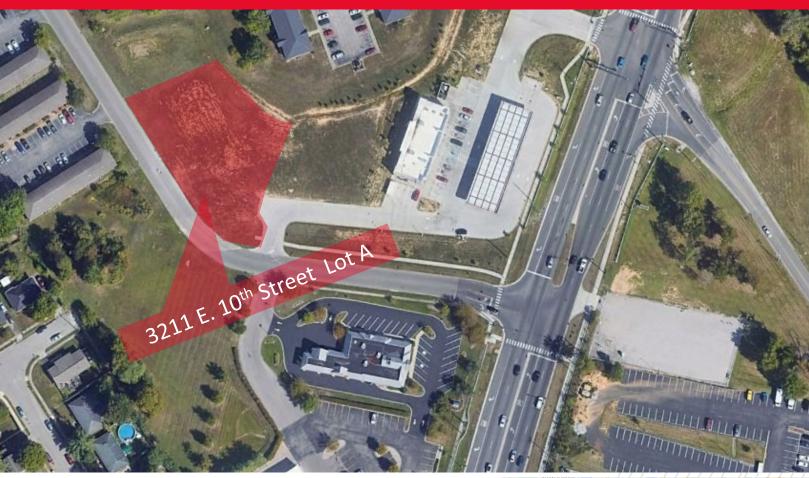

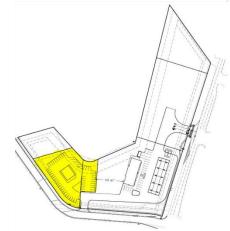
### LOCATION DESCRIPTION
