

CONFIDENTIALITY AGREEMENT

We have requested from LAYSAR INVESTMENTS LIMITED. We also agree not to use the information provided in any way detrimental to the Vendor or any parties assisting the Vendor. We agree to indemnify and save harmless the Vendor and Cushman & Wakefield from any claims, losses, damages and liabilities whatsoever (including legal fees and disbursements) arising out of a breach by us or any of our representatives of any of the terms or provisions of this Agreement. The obligations of confidentiality set forth in this Agreement shall terminate one (1) year after the date of this Agreement.
